#### **Clean and Low-Carbon Hydrogen**

- EGEDA noted the potential role of e-methane in economies reliant on imported LNG, emphasizing its ability to support the continued use of existing methane and gas infrastructure.
- EGCFE stressed the importance of the APEC Policy Guidance, calling for enhanced knowledge-sharing and collaboration.
- APERC is actively discussing follow-up actions on the APEC Policy Guidance with EGNRET and EGCFE, and plans to propose a new project.
- APSEC suggested organizing more workshops and targeted project submissions to advance hydrogen policy cooperation among expert groups.
